Conditions of Use

Mond Valley Golf Club Ltd monthly direct debit scheme, administered by "GoCardless" is offered to new and existing members on the condition that the membership fees are paid in full by 31 March 2027. Your monthly direct debit payment will include a 50/administration fee, and the golf shop staff will provide details of the members' monthly payments. After the 31 March 2027, the existing direct debit mandate will end, and a new mandate will need to be set up for next year.

- Please note: a member is liable for their FULL membership fees, regardless of whether they pay by lump sum or by direct debit monthly instalments. By using monthly direct debit payments Mond Valley Golf Club Ltd is permitting you to pay the full amount of your membership fees by monthly subscription.
- A member must not cancel any direct debit once they have signed the mandate. In the event of a serious injury, illness or financial difficulty, a direct debit may be suspended, but any request for a suspension must be made in writing to the Club Secretary.
- Please note: Mond Valley Golf Club Ltd will not offer any credits for any rain/flood affected days or any other circumstances which would result in the course or clubhouse being closed.
- If a direct debit is cancelled by a member without prior agreement, Mond Valley Golf Club Ltd will commence legal action to reclaim any

outstanding monies via the Small Claims Court. Any member who defaults on their payments will also be temporarily suspended until the matter is resolved.

- Mond Valley Golf Club Ltd reserves the right to adjust or amend the terms & conditions as necessary whilst efforts will be made to provide notice to members. Mond Valley Golf Club Ltd reserves the right to cancel a direct debit if these conditions are not adhered to.
- Members have a 7-day cooling off period from their joining date in which they can cancel their direct debit providing the services that have not been used during that time.
